

## Nuveen funds active share

as of 31 Mar 2025

Active share quantifies how differently a fund invests from its benchmark; the higher a fund's active share, the greater the difference. It is a particularly informative metric when looking at funds with broad and diversified indexes, such as the S&P 500®. Active share is one of many measures that can be used by investors to help identify if an investment manager is truly active.

Active share scores range from 0 to 100. An active share score of 0 indicates a portfolio that is identical to its primary benchmark index, while an active share score of 100 represents a portfolio composition that holds no overlapping positions. Different position allocation amounts contribute to active share score and are subject to change.
