## Nuveen AMT-Free Municipal Credit Income Fund Announces Intention to Redeem Preferred Shares

September 23, 2022 –Nuveen AMT-Free Municipal Credit Income Fund (NYSE: NVG) has filed with the Securities and Exchange Commission a notice of intention to redeem up to 2,500 shares in the aggregate of one or more series of the Fund's outstanding Variable Rate Demand Preferred Shares, MuniFund Preferred Shares and Adjustable Rate MuniFund Term Preferred Shares. The preferred share redemption price will be the \$100,000 liquidation preference per share, plus an additional amount representing the final accumulated dividend amounts owed. The Fund expects to finance the preferred share redemptions with cash on hand, portfolio sales and/or proceeds from the creation of tender option bond trusts. The redemptions are subject to market conditions and the completion of any necessary financing, and they may not occur as planned. Formal notification of redemption by the Fund will be delivered to holders of the applicable preferred share series at a later date through The Depository Trust Company (DTC).

The anticipated date of redemption (the actual date may be earlier or later, as indicated below) and the maximum number of shares for each series that may be redeemed are as follows:
