14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ► Nuveen Missouri Quality Municipal Income Fund merged into Nuveen Municipal High Income Opportunity Fund through the acquisition by Nuveen Municipal High Income Opportunity Fund of all the assets of Nuveen Missouri Quality Municipal Income Fund in exchange for voting shares of beneficial interest ("shares") of Common shares of Nuveen Municipal High Income Opportunity Fund and the assumption by Nuveen Municipal High Income Opportunity Fund of certain liabilities of Nuveen Missouri Quality Municipal Income Fund followed by the distribution by Nuveen Missouri Quality Municipal Income Fund of those shares pro rata to its shareholders in complete liquidation of Nuveen Missouri Quality Municipal Income Fund. The merger of Nuveen Missouri Quality Municipal Income Fund into Nuveen Municipal High Income Opportunity Fund qualifies as a tax free exchange within the meaning of Internal Revenue Code Section 368(a).

The exchange is based on the number and value of shares outstanding at the close of business on April 24, 2026.

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ► A shareholder's aggregate basis in the shares of Nuveen Municipal High Income Opportunity Fund the shareholder received in exchange for the shareholder's shares of Nuveen Missouri Quality Municipal Income Fund will be the same as the shareholder's aggregate basis in shares of Nuveen Missouri Quality Municipal Income Fund. The number of Nuveen Municipal High Income Opportunity Fund shares that were received for each share in Nuveen Missouri Quality Municipal Income Fund given up in the exchange is as follows:
