Each fund intends to distribute all or substantially all of its net investment income through its regular monthly distribution and to distribute realized capital gains at least annually. As a result, regular distributions throughout the year are expected to include net investment income and potentially a return of capital or capital gains for tax purposes.

Actual amounts and sources for tax reporting purposes will be determined as of the Fund's fiscal year-end and reported to shareholders on Form 1099-DIV.
