The principal reason for making this election is to reduce the amount of estate tax, but the election also has an effect on income tax because it means you will now use the later date to determine your basis.

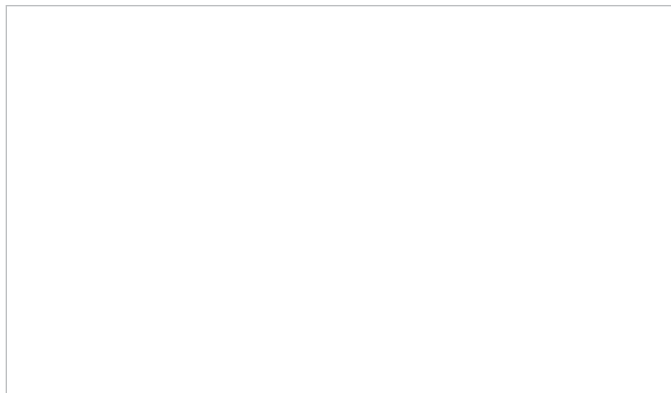

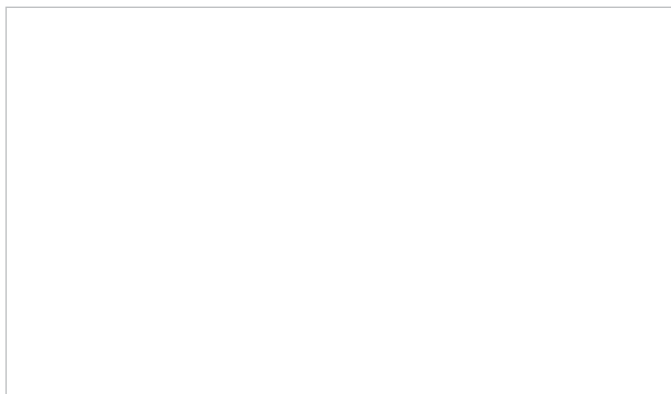
