Key takeaways

- The Nuveen Global Emerging Markets Debt Fund returned -0.93% in July, outperforming its benchmark, the J.P. Morgan Emerging Markets Bond Index (EMBI) - Global Diversified (-1.42%).
- Emerging markets (EM) debt posted negative returns for the month as spreads widened and rising U.S. rates amid the resumption of the conflict in Iran created a persistent risk-off tone. Within the EM space, sovereigns (-1.42%) declined the most given their longer-duration tilt, while corporates (-0.50%) were buffered by a shorter duration profile. Local currency markets delivered positive results (+0.30%) as the U.S. dollar weakened versus EM currencies.
- A more hawkish U.S. Federal Reserve, sticky inflation, rate volatility and spiking energy prices weighed on EM allocations, driving down flows relative to earlier months in 2026.

Contributors

Country allocation across both corporates and sovereigns proved beneficial to the Fund's relative performance. An underweight to Malaysia and a zero weight to the Philippines were particularly additive.

Security selection, especially corporate and quasi-sovereign holdings in Colombia, Mexico and India were key contributors in July. Exposure to Colombian food and beverage producers continued to aid relative returns, while off-benchmark subordinated financial positions provided a positive boost in both India and Mexico.

Yield Curve/duration positioning:

With U.S. rates rising during the period, the Fund's shorter duration posture, driven by our allocation to EM corporate debt, added value.

Currency (FX) positioning: Diversified exposure to local currency bonds contributed as well. Colombia and Nigeria were the best performers, while weaker issues from Ghana and Hungary offset some of the local segment's positive performance.

Detractors

Certain country exclusion and security selection decisions detracted from performance. Specifically, the Fund's lack of exposure to Lebanon, whose debt rallied from distressed levels, had a negative impact. Selections within Peruvian corporate debt also modestly hampered results as they underperformed their quasi-sovereign counterparts for the month.

Fund description

The strategy seeks to generate attractive risk-adjusted performance and compelling relative results versus its benchmark using a broad, diverse opportunity set of emerging market debt securities. The team invests across the full spectrum of emerging markets debt opportunities with a primary focus on hard currency denominated securities across sovereign, quasi-sovereign and emerging markets corporate issuers. Alpha is sought primarily through highly opportunistic country allocations and security selections.

The Fund is actively managed and is not managed in reference to a benchmark. Investors invest in shares of the Fund. Portfolio positioning

As of July month-end, the Fund's largest country overweight positions were in Steady issuers like Mexico, Colombia and India. These country-level exposures are broadly diversified across sovereign, quasi-sovereign and corporate debt. The largest underweights were the Philippines, Bahrain and China — none of which offers sufficient relative value, in our view.

From an EM sector perspective, the Fund is currently allocated 43% to sovereign debt, 9% to quasi-sovereigns, 40% to corporates and 7% to local currency. Portfolio duration remains about three-quarters of a year shorter than the benchmark's, while average credit quality is approximately one notch lower.

Outlook

Returns for EM debt through July have been supported by attractive yields and resilient fundamentals, and we remain relatively constructive on the asset class for the remainder of 2026. Rebuilt sovereign buffers, diminished currency risk and healthy corporate balance sheets continue to provide issuers with meaningful downside protection. Higher energy prices should benefit both the portfolio's exposure to corporate energy names as well as our regional overweighting of Latin America and Africa, which are more positively exposed to oil markets. Global rates have faced headwinds from sticky inflationary pressures over the past several months, while credit markets remain generally benign.
