NAM's Intermediate Government strategy begins by screening securities on fundamentals, technicals and valuation. This universe generally includes U.S. Treasuries and federal agencies rated at least A3/A-, generally limited to maturities up to 10 years.
- 10 The composite inception date is 01 Jan 2007; the composite creation date is 30 Sep 2007.
- For the period 01 Jan 2007 31 Dec 2010, this composite was managed by a team no longer affiliated with Nuveen Asset Management. As of 01 Jan 2011, a new team was formed when Nuveen Investments, Inc. acquired the long-term asset management business of FAF Advisors, Inc. and combined it with Nuveen Investment's wholly-owned subsidiary, Nuveen Asset Management. No material change in the investment process occurred.
- 12 The composite performance has been achieved at Nuveen Asset Management, LLC ("NAM").
- 13 The composite is benchmarked against the unmanaged Bloomberg Intermediate Government Index, which measures the returns of all publicly issued non-convertible domestic debt of the U.S. government or any agency thereof, or any quasi-federal corporation and of corporate debt guaranteed by the U.S. government. Only notes and bonds with minimum outstanding principal of \$1 million and minimum maturity of one year and maximum maturity of ten years are included. Benchmark returns are not covered by the report of independent verifiers.
- 14 The composite net-of-fees returns are calculated by deducting 1/12th of a model fee of 1.25%, which NAM reasonably believes is the maximum applicable fee, from the monthly "pure" gross-of-fee returns.

- 16 The three-year annualized standard deviation measures the variability of the composite and the benchmark over the preceding 36-month period and is calculated using gross returns.
