# **Strategy description**

Small/Mid Cap Value seeks to identify undervalued securities with small-to-mid-sized market capitalizations. The portfolio includes undervalued securities of companies in industries with positive or improving fundamentals.

- 4 The Small/Mid Cap Value composite (the "composite") incepted on 01 May 2006. The composite contains all discretionary institutional and dual contract/partially bundled fee portfolios managed within the Small/Mid Cap Value strategy. Prior to 01 Jan 2020, the composite consisted of all discretionary institutional portfolios managed within the strategy. Accounts in the composite use an approach which seeks to invest client assets primarily in common stocks of undervalued small to mid-sized market capitalization companies in industries with positive or improving fundamentals. Accounts in the composite also invest in foreign securities in the form of American Depositary Receipts (ADRs) and foreign corporations traded on U.S. exchanges. The composite name changed effective 01 Jan 2022 to "Small/Mid Cap Value"; the previous name was "NWQ Small/Mid Cap Value."
- 5 The composite's benchmark is the Russell 2500<sup>®</sup> Value Index. The Russell 2500<sup>®</sup> Value Index measures the performance of those Russell 2500<sup>®</sup> Index companies with lower price-to-book ratios and lower

- forecasted growth values. Index returns are provided to represent the investment environment during the time periods shown. For comparison purposes, index returns do not reflect transaction costs, investment management fees or other fees and expenses that would reduce performance in an actual account. It is not possible to invest in an index.
- 6 Composite and benchmark performance presented is calculated on a total return basis, which includes the reinvestment of all income, plus realized and unrealized gains/losses, if applicable.
