Fund description

The Fund employs a passive management (or "indexing") approach, investing primarily in large-capitalization U.S. equity securities that satisfy certain environmental, social and governance ("ESG") criteria.

Index description

The Nuveen ESG USA Large-Cap Index (the "Index") is primarily composed of equity securities issued by large capitalization companies listed on U.S. exchanges. The Index uses a rules-based methodology that seeks to provide investment exposure that generally replicates that of large-cap benchmarks through a portfolio of securities that adhere to predetermined ESG, controversial business involvement and low-carbon screening criteria. The Index is rebalanced on a quarterly basis. It is not possible to invest directly in an index.
