

Nuveen 2022 Indiana Shareholder Specific Information

Any interest earned from a direct obligation of the State of Indiana or a political subdivision of the State of Indiana is exempt from Indiana state income tax. Interest earned from a direct obligation of a state or political subdivision other than Indiana is subject to Indiana state income tax if the obligation is acquired after December 31, 2011. Interest earned from obligations held or acquired prior to December 31, 2011 is exempt from Indiana income tax. Our understanding is that the Indiana Department of Revenue is in the process of amending Indiana Income Tax Information Bulletin #19 to indicate that the relevant acquisition date which mutual fund shareholders should use to determine eligibility for the exemption is the acquisition date of the mutual fund shares on which the dividend is received. The following table provides the percentage of federally exempt-interest dividends included on box 12 of your 2022 1099-DIV that is received from direct state obligations other than Indiana. Please consider the acquisition date of your mutual fund shares when determining if some or all of the federally exempt-interest dividends may also be exempt from Indiana state income tax.
