* The Massachusetts state tax rate shown is the rate at which interest is generally taxed. Note that the 9.00% rate set forth in the table reflects the 4% surtax imposed on the portion of taxable income in excess of \$1,083,150. The \$1,083,150 taxable income threshold reflects the 2025 cost-of-living adjustment made to the statutory threshold of \$1,000,000. Such adjustment for tax year 2026 has not yet been released. In addition, note that a taxpayer may make an election which would result in interest and dividends being taxed at a higher rate. Certain other types of income are taxed at other rates. In addition, please note that the table does not reflect (i) any federal or state limitations on the amount of allowable itemized deductions or any phase-outs of exemptions or credits, (ii) any local taxes imposed or (iii) any alternative minimum taxes or any taxes other than personal income taxes. The Combined Tax Rate has been rounded to the nearest 1/10 of 1%. Further, please note that the Combined Tax Rate does not take into account the limited deductibility, if any, of state tax in computing federal tax. If this limited state tax deduction were taken into account in computing the Combined Tax Rate, the Combined Tax Rate (and corresponding taxable equivalent yields) for certain taxpayers would be lower than the chart indicates.

** This is the maximum stated regular federal tax rate of 37.0% plus the 3.8% medicare tax imposed on the net investment income of certain taxpayers. The medicare tax also applies to many taxpayers in other tax brackets.
