

Nuveen 2023 Utah Shareholder Specific Information

Interest from certain bonds, notes, and other evidences of indebtedness issued by non-federal governmental entities outside of Utah are subject to Utah income tax unless:

- 2) The issuing state (or political subdivision) does not impose an income tax on bonds issued by Utah or
