Strategy description

Municipal Total Return combines holdings of investment grade, intermediate municipal bonds with a commingled fund that allocates to municipal bonds across the credit spectrum. The strategy seeks to provide total return and tax-exempt income through a portfolio that combines two types of investments, with a target allocation that generally includes:

- 60% Intermediate Municipal separately managed account
- 40% Municipal Total Return Managed Accounts Portfolio¹

Investment process

Fundamental credit research is the foundation of the investment process. The municipal team considers economic outlook, credit analysis, trading and yield curve analysis when determining overall investment strategy. Targets and guidelines are developed for duration, yield curve positioning, security structure, sectors and credit quality. Portfolio managers construct portfolios through close collaboration with the credit research analysts and traders.

Municipal Total Return seeks attractive total return. The strategy also seeks to provide high current income exempt from regular federal income taxes. The strategy reflects a combination of approximately (i) 60% bonds according to NAM's Intermediate Term style; and (ii) 40% share in a registered investment company, Municipal Total Return Managed Accounts Portfolio, a specialized, registered investment portfolio offered only to Nuveen managed accounts. The specific allocation between bonds and fund shares may vary. The individual bond portion of the

strategy currently reflects an average portfolio maturity of generally 7 to 10 years and securities rated Baa3 or higher by Moody's and/or BBB- or higher by Standard & Poor's. The fund shares portion of the strategy reflect investment in various types of municipal securities, including investment grade rated BBB/Baa or better, below investment grade rated BB/Ba or lower (high yield), and unrated leveraged municipal securities. The fund focuses on securities with intermediate to longer term maturities. The fund may invest up to 50% of its net assets in high yield municipal bonds, but will normally invest 10-30% of its net assets in such bonds. The fund may invest up to 5% of its net assets in defaulted bonds. The fund may invest up to 50% of its net assets in leveraged municipal securities, most notably inverse floaters, which are securities that pay interest at rates that float inversely with changes in prevailing short-term interest rates. The credit quality of the bonds underlying all leveraged municipal securities will be rated A or higher, or, if unrated, judged to be comparable quality by NAM. To be included in the index, bonds must be rated investment-grade (Baa3/BBB- or higher) by at least two of the following ratings agencies (if rated by two or more agencies): Moody's, S&P, Fitch. Remarketed issues, taxable municipal bonds, bonds with floating rates, and derivatives, are excluded from the benchmark. The weighting of each security is based on its relative market value. **15** NAM's municipal fixed income accounts may significantly differ from a benchmark because some may have a state specific focus and they include selected securities whose weightings are based on discretion. **16** The strategy may frequently hold leveraged municipal securities, most notably inverse floaters, which are securities that pay interest at rates that float inversely with changes in prevailing short-term interest rates. **17** The composite net-of-fees returns are calculated by deducting 1/12th of a model fee of 1.25%, which NAM reasonably believes is the maximum applicable fee, from the monthly "pure" gross-of-fee returns. **18** Results are calculated in U.S. dollars. **19** From 01 Jan 2003 through 31 Dec 2013, accounts with significant cash flows (currently defined by NAM as an external flow [either in cash and/or securities] greater than 50% of an account's beginning market value for the month) were removed from a composite for the entire quarter in which the cash flow occurred; such accounts, as well as new accounts, were given a grace period for investment (4 to 6 weeks) before they are reviewed for inclusion in a composite.
