Part II Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action Nuveen Pennsylvania Municipal Value Fund merged into Nuveen AMT-Free Municipal Value Fund through the acquisition by Nuveen AMT-Free Municipal Value Fund of all the assets of Nuveen Pennsylvania Municipal Value Fund in exchange for voting shares of beneficial interest ("shares") of Common shares of Nuveen AMT-Free Municipal Value Fund and the assumption by Nuveen AMT-Free Municipal Value Fund of certain liabilities of Nuveen Pennsylvania Municipal Value Fund followed by the distribution by Nuveen Pennsylvania Municipal Value Fund of those shares pro rata to its shareholders in complete liquidation of Nuveen Pennsylvania Municipal Value Fund.
