## Monthly Capital Return Plan Policy Distribution

JQC has adopted a capital return plan through which the fund will return to shareholders 20 percent of the fund's common assets, over a period of three years ending on December 31, 2021, through supplemental amounts included in the fund's regular monthly distribution. Distribution sources have historically included net investment income and return of capital, and may also include realized gains in the future. It is expected under the capital return plan that regular monthly distributions will include supplemental amounts in addition to net investment income which would normally represent either realized gains or a return of capital, and the fund will provide a notice of the best estimate of its distribution sources at that time, which may be viewed at [www.nuveen.com/CEFdistributions](http://www.nuveen.com/CEFdistributions). These estimates may not match the final tax characterization (for the full year's distributions) contained in shareholders' 1099-DIV forms after the end of the year.

## Monthly Taxable Managed Distributions

The goal of a fund's managed distribution program is to provide shareholders relatively consistent and predictable cash flow by systematically converting its expected long-term return potential into regular distributions. As a result, historical distribution sources have included net investment income, realized gains and return of capital. If a distribution includes anything other than net investment income, the fund provides a notice of the best estimate of its distribution sources at that time which may be viewed at [www.nuveen.com/CEFdistributions](http://www.nuveen.com/CEFdistributions). These estimates may not match the final tax characterization (for the full year's distributions) contained in shareholders' 1099-DIV forms after the end of the year.

Under a Managed Distribution policy, each of the funds listed immediately below seeks to maintain an attractive and stable regular distribution amount that, over the long term, matches the fund's total distributions paid to its total return. A return of capital is a non-taxable distribution of a portion of the fund's capital. When fund returns exceed distributions, return of capital may represent portfolio gains earned, but not realized as a taxable capital gain. In periods when fund returns fall short of distributions, it will represent a portion of your original principal unless the shortfall is offset during other time periods over the life of your investment (previous or subsequent) when the fund's total return exceeds distributions.
