# Municipal yield curve maturity ranges



### Glossary

Average effective maturity is a weighted average of all the stated maturities of the bonds in a portfolio except in cases where the bond has been advance-refunded and secured by an escrow to an earlier redemption date, or where the bond is subject to an optional or mandatory tender or put provision. Effective duration is for a bond with an embedded option when the value is calculated to include the expected change in cash flow caused by the option as interest

rates change. This measures the responsiveness of a bond's price to interest rate changes, and illustrates the fact that the embedded option will also affect the bond's price. The S&P Municipal Bond Short Index consists of bonds in the S&P Municipal Bond Index with a minimum maturity of 6 months and a maximum maturity of 4 years. The S&P Municipal Bond Short-Intermediate Index consists of bonds in the S&P Municipal Bond Index with a min maturity of 1 year and a max of 7.999 years. The S&P Municipal Bond Intermediate Index consists of bonds in the S&P Municipal Bond Index with a minimum maturity of 3 years and a maximum maturity of 15 years. The S&P Short Duration Municipal Yield Index consists of bonds maturing in 1 to 12 years and is structured so that 70% of the market value of the index consists of bonds that are either not rated or are rated below investment grade, 20% are rated BBB/Baa, and 10% are rated single A. The **S&P Municipal Bond Index** is a broad, market value-weighted index that seeks to measure the performance of the U.S. municipal bond market. The S&P Municipal Yield Index is structured so that 70% of the market value of the index consists of bonds that are either not rated or are rated below investment grade, 20% are rated BBB/Baa, and 10% are rated single A.
